Re: Off-Floor DPM Program

---

The Market Quality and Allocation Committee has approved Susquehanna Investment Group ("SIG") as an Off-Floor DPM in approximately 649 equity option classes (please see attached list of classes). SIG will begin acting as the Off-Floor DPM in these classes according to the following schedule:

- All classes currently located at Post 3, Station 1 and Post 3, Station 10 will be allocated to SIG as an Off-Floor DPM effective February 25, 2009.
- All classes currently located at Post 3, Station 3, Post 3, Station 6 and Post 3, Station 9 will be allocated to SIG as an Off-Floor DPM effective March 6, 2009.

These 649 option classes will physically remain in their respective Market-Maker trading crowds. A SIG representative will be present in each trading crowd for the purposes of facilitating this transition. Additionally, members may contact a SIG representative directly (SIG is making available to all members a contact list, which SIG refers to as its Symbol Lookup Tool; for further information and/or installation of the Symbol Lookup Tool, please contact James Lipinski, SIG, at 312-435-4182).

Any new option classes allocated to SIG as an Off-Floor DPM will be physically located at Post 3, Station 1, Station 3, Station 6, Station 9 or Station 10, to be determined by the Allocation Subcommittee.
